

# Absentee Voter Application

## Who is an Absentee Voter?

Any qualified voter who is unable to vote on election day or on a day when advance polling takes place.

**Qualified Voter** – To vote in the by-election, you must:

- ✓ Be a Canadian citizen on or before election day, or be a British subject who was qualified as a voter on June 23, 1971;
- ✓ Be at least 18 years old;
- ✓ Have lived in Saskatchewan for at least the six months before the day the election is called; and
- ✓ Be ordinarily a resident in the constituency on the day the election is called.

**Ordinary Residence** – Under Section 18 of *The Election Act, 1996* ordinary residence means the place where the voter “has established habitation” which, when the person is absent from it, the person intends to return.

## When Can I Apply?

A qualified voter may apply for an absentee ballot as soon as the application is made available, but **no later than eight days before election day**. You must apply directly to the returning officer in the constituency in which your ordinary residence is located or to the Chief Electoral Officer.

Addresses for returning offices will be published in all local newspapers and posted on the Elections Saskatchewan website ([www.elections.sk.ca](http://www.elections.sk.ca)) once the writ is dropped. If you are applying before the writ is dropped, please mail, email or fax your application to:

Legislation states that we can send out the Absentee Ballot Kit as soon as the writ of election is called. This means that your Absentee Ballot Kit will be sent to you when the writ is dropped.

## How Does an Absentee Voter Vote?

Once you receive your Absentee Ballot Kit in the mail, an absentee voter marks the ballot paper provided by writing in the blank space the name or political affiliation of the candidate for whom the voter intends to vote. The marked ballot is then returned to the returning office in the voter's constituency to be held until the final count.

A series of envelopes is used to protect the secrecy of the vote. The envelopes are accompanied by a declaration that certifies the voter is eligible to vote, and has not voted, nor will vote a second time.

## Completing the Application

The application form consists of three parts. All three parts must be completed.

**Part I** the application portion, includes your name, ordinary residential address and mailing address of the applicant (if different from ordinary residential address).

**Part II** sets out the address where the Absentee Ballot Kit is to be mailed if different than the address in Part I.

**Part III** is the declaration of the voter confirming that they are an eligible voter.

## IMPORTANT

**Your application will not be processed unless it is accompanied by a copy of your identification documents.**

**See back of this page for list of acceptable identification.**

### Deadline

The returning officer or Chief Electoral Officer must receive your completed application and a copy of your identification documents **no later than eight days before election day**.

An absentee voter application and declaration may also be made by facsimile or other means of electronic transmission provided that the signature on the application is graphically represented.

# Identification Requirements and Contact Information

You have two options:

**You must** attach a copy of one original piece of identification with your photo, name and residential address. It must be issued by a government agency.

Example: **driver's licence**

OR

**You must** attach photocopies of two original pieces of authorized identification. Both pieces must have your name and one must also have your address.

Example: **health card and power bill**

## Acceptable ID Options

The address on your identification must match the address you have listed on the application as your ordinary residential address.

- I have ordinarily resided in Saskatchewan for at least six months immediately preceding the day the writ was issued;
- I was ordinarily resident in the above-mentioned constituency on the day the writ was issued;
- I am not disqualified pursuant to section 17 of *The Election Act, 1996* to vote at this election;
- I am unable to vote at an advance poll or on election day in the constituency in which I am an ordinary resident; and
- I have not already voted at this election.

I understand that upon issuance of an Absentee Ballot Kit under the absentee voters provisions, I will be deemed to have voted.  
I make this solemn declaration conscientiously, believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of *The Canada Evidence Act*.
